RELEASE OF LIABILITY AGREEMENT -RIDERS/DRIVERS ON UNICORN FARM PROPERTY

ST AUGUSTINE PONY CLUB, UNICORN FARM PROPERTIES, WILLIAM H. WRIGHT FAMILY TRUST, and HELENA A. duPONT WRIGHT, Trustee, (hereinafter collectively referred to as "Owner") and the undersigned adult participant, or the undersigned parent or guardian of a minor child participant (hereinafter referred to as "Participant") on the day of agree as follows:

Owner provides equine training facilities, including but not limited to land, stables, riding arenas, cross country fences, driving obstacles and trails on the real property described on "Exhibit A" (hereinafter referred to as "Facilities"). Participant uses the Facilities for the purpose of boarding, riding lessons, training, schooling and/or showing of Participant's horse(s), either in an organized activity, or with Participant acting on his or her own. Participant has inspected the Facilities carefully and has found them safe and acceptable. Participant is aware that surface and subsurface conditions of the Facilities, including the land, trails and pond will change from time to time due to weather and previous use by riders/drivers, particularly in the immediate vicinity of cross country fences and obstacles. Participant is aware of the varying difficulty of fences, cross country fences and driving obstacles, and has represented that the Participant and his or her horse(s) is fully capable of using the Facilities. Participant is aware of the inherent risk of an equine activity due, but not limited to, the propensity of the horse to react unpredictably and the Participant's inability to control the horse(s) in some circumstances. Participant agrees to release, hold harmless and absolve Owner from any claim which the Participant may have against the Owner for any negligence or acts or omissions which may cause any injury to the Participant while riding on or using the Facilities. IN CONSIDERATION OF Owner allowing the Participant to use the Facilities, PARTICIPANT AGREES TO RELEASE THE OWNER, WAIVE ALL CAUSES OF ACTION AGAINST THE OWNER, AND HOLD HARMLESS AND INDEMNIFY Owner, its agents and employees, against any and all actions arising from any injury, loss, damage or death of the Participant or the Participant's horse while at or using the Facilities. This agreement will continue in full force and effect during any time that the Participant is using the Facilities.
